The agenda was already circulated to the members by e-mail. The outcome of the meeting is given below:

- Declaration of ISAS-DC executive committee elections for the period of 2021 to 2024.
- It was discussed that as per Laws/by-laws of the society, the immediate past Chairman, shall on expiry of his term of office, become ex-officio member of the committee for the second term. In order to take benefit from rich experience and knowledge of outgoing Chairman (unless he/she is not interested to context for some other position), a new post of President was created by EC of ISAS-DC for the term 2021-24 onwards. In case immediate past Chairman is not available for the President position, EC may select a suitable person, provided he/she is an individual having membership of ISAS-DC at least for last 15 year, and should have previous experience as office bearers in EC of ISAS-DC for at least two terms in last 10 years. President of the ISAS-DC shall have the rights and privileges of the members of the ISAS-DC except the voting rights and the right to hold elective office and shall be exempted from payment of subscription.
- Mr Dinesh Kumar, IOC R&D has been appointed as Chief returning officer for elections for 2021-24.
- EC suggested few changes in election nomination form due to covid pandemic as members can not physically sign the nomination form.
- EC decided to have only one account for ISAS-DC. SBI, IOC Complex, Faridabad will be used for ISAS-DC activities and Syndicate bank, NIT, Faridabad will be closed after transferring balance amount in Syndicate bank to SBI.

- EC approved to continue Mr Rajeev Jain as auditor for 2020-21 to audit ISAS-DC accounts / activities.
- GBM will be held after the election of new EC
- EC appreciated the efforts of Dr. Ravidra Kumar for his efforts to change the name on ISAS-DC in the PAN card and registration of society in Haryana. Successfully.
- In view of elections, future activity of ISAS-DC will be decided after the election of new EC.
